



## **Keenesburg Municipal Code Sec. 4-7-40 Development impact fees imposed**

Obligation to pay and time of payment. After the effective date of the ordinance enacting this Article, any person who causes the commencement of impact-generating development shall be obligated to pay impact fees pursuant to the terms of this Article. The obligation to pay impact fees shall run with the land. The amount of the impact fees shall be determined in accordance with Section 4-7-60 and paid to the Town at the time and as a condition of issuance of a building permit for the new development. If any credits are due pursuant to this Article, they shall be determined at that time.

### **Impact Fees**

- **Water Tap Fees, Effective July 1, 2019**

- Single Family and nonresidential:

- ¾" tap \$ 6,490
- 1" tap \$11,036
- 1 ½ tap \$22,721
- 2" tap \$38,945

- **Multifamily Residential:** \$3,575 per unit

- **Raw Water Acquisition Fee, Effective February 1, 2020**

Keenesburg requires that annexations dedicate the underlying groundwater to the Town. The true cost of raw water includes the cost to drill wells, install pump stations, and pipe the water to a central gathering location where the raw water can be treated. This fee is paid by the developer on each individual new build.

- Single Family residential and nonresidential:

- ¾" tap \$10,910
- 1" tap \$18,545
- 1 ½" tap \$38,181
- 2" tap \$65,453

- **Multifamily Residential:** \$6,545 per unit

- **Sewer Tap Fees, Effective July 1, 2019**

- Single Family and nonresidential:

- ¾" tap \$ 7,429
- 1" tap \$12,629
- 1 ½" tap \$26,003
- 2" tap \$44,577

- **Multifamily Residential:** \$4,092

- **Drainage Fees**
  - Single Family Residential, per lot: \$0.187, *see EXHIBIT A (calculation)*
    - Drainage impact fees will only be assessed in the Park and Ash Hollow Drainage Basins (see Exhibit B) when on-site detention is not provided. Drainage impact fees for all development permits will be assessed based on each square foot of the impervious area.
  - **Multifamily Residential** per unit: \$0.187 *see EXHIBIT A (calculation)*
    - *Commercial/Retail, all others see EXHIBIT A*
  
- **Parks Impact Fee**
  - Single Family Residential per lot: \$2,369
  - Multi-family Residential per unit: \$1,775
  
- **Roadway Street Impact Fee**
  - Single Family Residential per lot: \$2037
  - Multi-family Residential per unit: \$1529
  - Commercial/Retail & all others, see Exhibit A*
  
- **Town Hall Impact Fee**
  - Single Family Residential per lot: \$1,652
  - Multi-family Residential per unit: \$1,775
  - Commercial/Retail/Office \$1,652
  - Warehouse/Industrial/Institutional \$1,652
  
- **Police Impact Fee**
  - Single Family Residential per lot: \$209
  - Multi-family Residential per unit: \$160
  - *Commercial/Retail/Office/Warehouse/Industrial/Institutional – See Exhibit A*
  
- **Fair Contributions for Public School Sites Impact Fee, Effective 6-5-2020**
  - Single Family Dwellings (incl. mfg. housing): \$2,232.62 per unit
  - Two Family Dwellings (incl. mfg. housing): \$1,226.00 per unit
  - Multi Family Dwellings (incl. mfg. housing): \$1,342.15 per unit
  - Residential Only*
  
- **Emergency Services Impact Fee effective 6-22-20**
  - Residential Dwelling: \$1,835.00 per unit
  - Commercial/Non-Residential Building: \$1.07 per sq. ft. of floor area
  
- **Use Tax Fee**
  - Use Tax is 3% of the estimated cost of building materials charged on all permits
