Recent legislation passed by the Colorado Legislature in 2018 requires that Courts in Colorado ascertain whether or not a defendant is serving in the United States Armed Forces or is Veteran of such forces. Courts are required to inform any such defendant that he or she may be entitled to receive mental health treatment, substance use disorder treatment, or other services as a Veteran. Veteran's Treatment Courts are established throughout the Courts in Colorado.
