Water Rate Increase

The Board of Trustees has reviewed a new water rate schedule and has determined that the new fee structure will bring the water rates to an equitable fee for all users. The new rates will go into effect February 1, 2020. The Board will be considering a resolution on December 16, 2019 for the new fee structure. Water users will see an increase in their water bill between 10-23% depending upon the water consumption. The new rate structure will have a base fee determined by the tap size, and four tiers of usage levels. The proposed rates are as follows:

Tap Size Base Rate:	3/4" tap	\$27.00
	1" tap	\$38.00
	1 1/2" tap	\$68.00
	2" tap	\$95.00
	3" tap	\$162.00

Residential and Commercial Water Usage rates:

0 to 6,000 gallons	\$2.75 per each thousand gallons or portion thereof
6,001 to 20,000 gallons	\$3.50 additional per thousand gallons or portion thereof
20,001 to 40,000 gallons	\$4.50 additional per thousand gallons or portion thereof
40,001 gallons or more	\$7.75 additional per thousand gallons or portion thereof

Town Manager's Report

Pioneer Village: The Town has approved an annexation for Pioneer Village consisting of 2182 acres located East of CR 49 between CR 28 and 22, as well as a sketch plan for a mixed use development at that location. The next step in the development process will be a submittal for a preliminary and final plat. These applications have not yet been received but are expected in the next several weeks.

Market Street Mart: The Town has received an application for an expansion at Market Street Mart for a new convenience store.

Market Street Business Park: This subdivision is located at the Northwest corner of I-76 and Market Street and is planned to have 4 lots varying in size from 0.81-4.14 acres for commercial type uses. This subdivision was approved on December 2, 2019, and is expected to move forward with construction in the coming months.
