Evan's Place Subdivision filing 2: LGI has submitted its application for Evans Place Filing 2. Public hearings have been scheduled in front of the Planning Commission on Thursday, April 4, and in front of the Board of Trustees on Monday, April 15, 2019.

Update on Town Projects:

Sewer Repair and Rehabilitation: All work that will be completed on the sewer repair project is now done. I am sure many of you have wondered why there was construction on Woodward again. Milestone Companies LLC is working on punch list items that need to be corrected prior to final acceptance by the Town. When the Town enters into a contract for public improvements, those improvements must be inspected and accepted by the Town before the project is final. Unfortunately, there was a deficiency in the repair that was done on the sewer line on Woodward; this is the reason for the street closure to assure quality and functional repairs are completed before the project is finalized. We apologize for any inconvenience this may have caused and thank you for your patience as we work through any items that require correction.

Centennial Celebration: The town will be constructing a band shelter at Schey park in advance of the centennial celebration. We will begin plan review for this project in the very near future.

Welcoming signage Woodward & Elm: The scope of work for the design of this property will go out for bid in the next week. There will be more information to follow on this project.
