Dog License Renewal

KMC 7-6-20 states all dogs within town limits must be licensed. All dog licenses expired May 31, 2019. In order to license your dog, you must provide proof of rabies, distemper and parvo vaccinations by a licensed veterinarian; it is \$5 per dog, with a maximum of three dogs. Census 2020: Avoiding Fraudulent Activity and Scams

Recent reports have surfaced of confusing mailers being sent to residents of at least six states, including Colorado, using the word "census" to ask for information and money. Please be aware of the following guidelines to avoid fraudulent activity that may increase as we approach Census Day (April) 2020

The Census Bureau never asks for:

- Money or donations
- Full Social Security Numbers
- Anything on behalf of a political party
- Full bank or credit card account numbers
- Your Mother's Maiden Name

Town Manager’s Report

The following application has been received and is currently being reviewed:

Evan’s Place Subdivision filing 2: Evan’s Place is located north of CR 398 between CR 59 and N Ash Street and is comprised of approximately 73 acres on the north side of the railroad tracks. LGI Homes is the developer and they have been approved for Filing I and II of Evans Place. Filing I consists of 211 homes and construction is now underway.

Rocky Mountain Midstream Water Main: The water main extension from the Wild Country RV Park to the Keenesburg Gas Plant located on CR 398 is approximately 2/3 complete.


Rocky Mountain Midstream Annexation: RMM has requested annexation of approximately 286 acres located east on CR 398 and is bordered to the east by Expedition Water Solutions. The applicant is requesting heavy industrial zoning compliant with the town’s comprehensive plan. Both the zoning and annexation was approved on May 6, 2019.

Cook Annexation: George Trent Cook has requested annexation of his property located on the corner of CR 51 and 20. This property consists of approximately 156 acres, and he has requested heavy industrial zoning that is compliant with the Town’s comprehensive plan. This is a flagpole annexation that includes the annexation of Weld County ROW along CR 18, north on CR 49, east on CR ROW 20 to reach the property. The zoning and annexation of this property was approved on May 20, 2019.

Hardware Hank and relocation of Keene Auto: Keene Auto is relocating and expanding to include Hardware Hank at 105 South Main Street. The site plan for this project has been approved and the transformation is underway.

Update on Town Projects:

Centennial Celebration: The town has scheduled the centennial celebration for Saturday July 20, 2019. The centennial committee has been working diligently to plan for this event. This promises to be a fun-filled day that will include free food, games, and entertainment from 2-8p.m. Please save the date!



Welcoming signage Woodward & Elm: This project has been awarded to the Architerra Group in Lakewood. The kick-off meeting for this project is scheduled for Wednesday, June 6, 2019. Designs are planned to be available at the Centennial Celebration on July 20, 2019.

Elm Street Sidewalk Project: This project has been awarded to Straight Line Sawcutting, the Board approved the contract on June 3, 2019. Construction of the new sidewalks along Elm Street will begin on Wednesday, June 6, 2019. New sidewalks will be installed along the west side of Elm street from Woodward to the mid-block of Elm Street. This project includes the installation of six new handicap ramps, including a curb and gutter along Woodward Avenue along the newly obtained town parcel on the corner of Elm and Woodward.

Water Tank Painting Project: This project was awarded to M & M Tank Company, and is expected to begin near the end of July. This project includes the exterior painting of the water tank located on North Cedar Street, as well as the old water storage tank located at CR 55 and 14. Due to delays caused by weather, this project will not be completed prior to the Centennial Celebration.

As you can see, it is shaping up to be a very busy summer and fall as we work to complete projects that are weather sensitive and development moves forward. With progress comes some inconveniences, please be patient as there will be several locations that will have traffic control in place; there will be times that lanes will be reduced to one way. This traffic control will be in place for the safety and protection of the workers, please obey the traffic signage while driving in those areas.
